# **Chinese Restaurants (CHR-2023A)**

## TARIFF FOR THE PUBLIC PERFORMANCE OF SOUND RECORDINGS

Effective 1 January 2023

- 1. This tariff applies to the public performance of sound recordings, solely as background music, in Chinese restaurants within the repertoire of HKRIA.
- 2. This royalty rate shall not apply to:
  - Functions / Events held within the Chinese restaurant such as 婚宴, 聯歡宴, 全包宴, etc. for which a separate licence is required.
  - Juke Box(es)
  - Karaoke Performance
- 3. Licence Fee:

Not exceeding 50 seats	HK\$115.00 per seat per annum
51 – 100 seats	HK\$92.00 per seat per annum
101 – 200 seats	HK\$71.00 per seat per annum
201 seats or above	HK\$23.00 per seat per annum

- e.g. For a Chinese restaurant with maximum accommodation of 120 seats: The total licence fee will be: (\$115.00 x 50 + \$92.00 x 50 + \$71.00 x 20) = HK\$11,770.00
- 4. Minimum Licence Fee: HK\$5,520.00 per restaurant per annum
- 5. General Conditions
  - a) Licence Fee is payable in advance of each Licence Year for unlimited public performance of any or all sound recordings within HKRIA's repertoire at a single premises (i.e. a consecutive period of twelve calendar months commencing on the first day of a month in which the Licence incorporating this tariff is executed).
  - b) The classification of any premises under Chinese Restaurants of this tariff shall be at the sole discretion of HKRIA.
  - c) This tariff rate may be revised from time to time by HKRIA.
  - d) This tariff, Chinese Restaurants (CHR-2023A), supersedes all previous editions of tariffs for Chinese Restaurants and shall have effect from 1<sup>st</sup> January 2023.
